

# PETROLEUM ACT 1998

## Notice of Application for a Submarine Pipeline Works Authorisation

Shell U.K. Limited hereby gives notice on behalf of itself, One-Dyas E&P Limited and Rockrose UKCS4 Limited, in accordance with the provisions of Part I of Schedule 2 to the Petroleum Act 1998 that it has made an application to the Oil and Gas Authority for the grant of an authorisation for the construction and use of a system of pipelines between the Arran North Tie-In Structure and the Riser Connection Point at Shearwater 'A' Platform.
